



# The Municipal Corporation of the Town of Fort Erie

## By-law No. 130-2016

---

**Being a By-law to Amend Traffic By-law No. 2000-89 –  
3-Way Stop on Thunder Bay Road at Bernard Avenue –  
Parking Prohibition on South Side of Queen Street  
(Central Avenue to Goderich Street) –  
Re-Establishment of Courtwright Street as Through Street  
(Central Avenue to Klauck Street)**

**Whereas** By-law No. 2000-89, as amended, provides for the regulation of traffic and parking on highways in the Town of Fort Erie; and

**Whereas** Report No. IS-44-2016 was considered at the Council-in-Committee Meeting held on November 21, 2016 and subsequently authorized and approved by Council, to approve the installation of a 3-way stop at the intersection of Thunder Bay Road and Bernard Avenue; and

**Whereas** Report No. IS-45-2016 was considered at the Council-in-Committee Meeting held on November 21, 2016 and subsequently authorized and approved by Council, to approve the installation of "No Parking" prohibitions on the south side of Queen Street from Central Avenue to Goderich Street; and

**Whereas** Report No. IS-46-2016 was considered at the Council-in-Committee Meeting held on November 21, 2016 and subsequently authorized and approved by Council, to approve the re-establishment of Courtwright Street as a through street from Central Avenue to Klauck Street; and

**Whereas** it is deemed desirable to amend Traffic By-law No. 2000-89, as amended, accordingly;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** Schedule "C" to By-law No. 2000-89, as amended, is further amended by inserting the following:

2. **That** Schedule “M” to By-law No. 2000-89, as amended, is further amended by inserting the following:

3. **That** Schedule “N” to By-law No. 2000-89, as amended, is further amended by inserting the following:

4. **That** Schedule “R” to By-law No. 2000-89, as amended, is further amended by deleting the following:

5. **That** this by-law shall be enforceable upon the installation of the appropriate signage as required for each of the above amendments.

6. **That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.
