

The Municipal Corporation of the Town of Fort Erie

By-law No. 130-2016

Being a By-law to Amend Traffic By-law No. 2000-89 –
3-Way Stop on Thunder Bay Road at Bernard Avenue –
Parking Prohibition on South Side of Queen Street
(Central Avenue to Goderich Street) –
Re-Establishment of Courtwright Street as Through Street
(Central Avenue to Klauck Street)

Whereas By-law No. 2000-89, as amended, provides for the regulation of traffic and parking on highways in the Town of Fort Erie; and

Whereas Report No. IS-44-2016 was considered at the Council-in-Committee Meeting held on November 21, 2016 and subsequently authorized and approved by Council, to approve the installation of a 3-way stop at the intersection of Thunder Bay Road and Bernard Avenue; and

Whereas Report No. IS-45-2016 was considered at the Council-in-Committee Meeting held on November 21, 2016 and subsequently authorized and approved by Council, to approve the installation of "No Parking' prohibitions on the south side of Queen Street from Central Avenue to Goderich Street; and

Whereas Report No. IS-46-2016 was considered at the Council-in-Committee Meeting held on November 21, 2016 and subsequently authorized and approved by Council, to approve the reestablishment of Courtwright Street as a through street from Central Avenue to Klauck Street; and

Whereas it is deemed desirable to amend Traffic By-law No. 2000-89, as amended, accordingly;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. That Schedule "C" to By-law No. 2000-89, as amended, is further amended by inserting the following:
