

The Municipal Corporation of the Town of Fort Erie

By-law No. 131-2016

Being a By-law to Authorize Applications for the Cancellation, Reduction or Refund of Taxes Levied for the Years 2013, 2014, 2015 and 2016

Whereas pursuant to Sections 357 and 358 of the *Municipal Act, 2001,* as amended, an owner or another person with an interest in a property may make application for the cancellation, reduction or refund of taxes levied in respect of an event that affects the assessment or an overcharge; and

Whereas Report No. CS-26-2016 was considered at the Council-in-Committee Meeting held November 21, 2016 and subsequently authorized and approved by Council for the cancellation, reduction or refund of taxes and penalties in the amount of \$19,800.18;

Now therefore the Council of the Town of Fort Erie enacts as follows:

- **1. That** the applications received for tax adjustments totalling \$19,800.18 for various roll numbers attached as Schedule "A" to this by-law, are accepted and approved.
- 2. That the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 28th day of November, 2016.
