## By-law No. 135-2016

---

### Being a By-law to Adopt the Preliminary Capital Budget for the Town of Fort Erie for the Year 2017

---

**Whereas** Section 290 of the *Municipal Act, 2001* provides that a local municipality shall for each year prepare and adopt a budget including estimates of all sums required during the year for the purposes of the municipality; and

**WHEREAS** Report No. CBC-01-2017, as amended, was considered at the Council-in-Budget Committee Meeting held on November 16, 2016 and subsequently authorized and approved by Council, to approve the 2017 Preliminary Capital Budget and defer approval of the balance of the 2017 Capital Budget to February 27, 2017 with the consideration of the 2017 General Levy Budget By-law; and

**WHEREAS** in accordance with Public Notice Policy By-law No. 206-07 public notice of the budget meeting schedule and by-law adoption was published in the Fort Erie Times November 24, 2016, posted on the Town of Fort Erie website and listed on Council and Council-in-Committee Agendas; and

**WHEREAS** it is deemed desirable to adopt the Preliminary Capital Budget for the Town of Fort Erie for the Year 2017 as set out herein;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** the 2017 Preliminary Capital Budget attached as Schedule "A" and forming part of this by-law is approved and adopted.
2. **That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

**Read a first, second and third time and finally passed this 5th day of December, 2016.**
