

## The Municipal Corporation of the Town of Fort Erie

By-law No. 9-2017

Being a By-law to Authorize the Entry into and Execution of a Collaboration Agreement with The Niagara Parks Commission to Facilitate a Transfer Payment Agreement with the Ministry of Transportation under the Ontario Municipal Cycling Infrastructure Program for the Niagara River Recreational Trail: Riverwalk to Bridgeburg Project

Whereas the Ministry of Transportation (MTO) established the \$10 million Ontario Municipal Cycling Infrastructure Program (OMCIP) to help municipalities build new and improved existing cycling infrastructure; and

**Whereas** the Town of Fort Erie (Town) and The Niagara Parks Commission (NPC) entered into a Letter of Intent on November 26, 2015 to facilitate an application to the OMCIP for the Niagara River Recreational Trail: Riverwalk to Bridgeburg Project (Project) and were subsequently approved subject to an executed Collaboration Agreement between the Town and NPC; and

**Whereas** the total project budget is \$500,000 with a \$150,000 contribution from NPC, and a \$100,000 contribution from the Town which was approved by By-law No. 23-2016 (To Adopt the General Capital Budget and the General Levy Operating Budget for the Town of Fort Erie for the Year 2016) on February 22, 2016; and

**Whereas** Report No. PDS-01-2017 was considered at the Council-in-Committee Meeting held on January 16, 2017, and subsequently approved to authorize the execution of a Collaboration Agreement with NPC, as required to receive funding through the Ontario Municipal Cycling Infrastructure Program, and to authorize the execution of a Transfer Payment Agreement with the MTO relative to the OMCIP funding for the Project; and

Whereas it is deemed expedient to authorize the entry into and execution of a Collaboration Agreement with NPC in order to facilitate the OMCIP Transfer Payment Agreement with the MTO for a grant allocation in the amount of \$250,000.00 for the aforesaid Project;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. That the entry into a Collaboration Agreement with The Niagara Parks Commission in order to facilitate an OMCIP Transfer Payment Agreement with the MTO for the Niagara River Recreational Trail: Riverwalk to Bridgeburg Project is authorized and approved.

2. That the Mayor and Clerk are authorized and directed to execute the Collaboration Agreement, in a form satisfactory to the Town Solicitor, and to affix the corporate seal thereto.

**That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 23<sup>rd</sup> day of January, 2017.
