

## The Municipal Corporation of the Town of Fort Erie

By-law No. 22-2017

## Being a By-law to Amend Zoning By-law No. 129-90, as Amended – Removal of Holding Provision Village Creek Phase 3 (800547 Ontario Limited – Ed Lenchyshyn)

Whereas the Municipal Council of The Corporation of the Town of Fort Erie passed By-law No. 45-2016 on the 11<sup>th</sup> day of April 2016, rezoning certain lands within the Village Creek Phase 3 subdivision generally located on the east side of Ott Road, south of West Main Street to "Residential 2 R2-552 (H) Zone", "Residential 2 R2-553 (H) Zone" and "Residential Multiple 1 RM1-554 (H) Zone" with a Holding provision preventing the development of the lands until Council approved a Subdivision Agreement for the lands; and

**Whereas** the Municipal Council of The Corporation of the Town of Fort Erie passed By-law No. 137-2016 on the 12<sup>th</sup> day of December 2016, approving a subdivision agreement between The Corporation of the Town of Fort Erie and 800547 Ontario Limited for Village Creek Phase 3; and


**Whereas** Upper Canada Consultants, the agent for the owner, requested the holding provision be removed in a letter dated September 21, 2016;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

- 1. That Schedule "A" of By-law 129-90 as amended is further amended by changing the zoning on the lands shown on the attached Appendix "1" from "Residential 2 R2-552 (H) Zone", "Residential 2 R2-553 (H) Zone" and "Residential Multiple 1 RM1-554 (H) Zone" to "Residential 2 R2-552 Zone", "Residential 2 R2-553 Zone" and "Residential Multiple 1 RM1-554 Zone."
- 2. That the Clerk of the Town is authorized to effect any minor modifications, corrections, or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 13" day of February, 2017.
