

The Municipal Corporation of the Town of Fort Erie

By-law No. 88-2017

Being a By-law to Authorize the Entry into an Extension and Amending Agreement with Tokmakjian Inc. for the Provision of Conventional Public Transit Service

Whereas the Town of Fort Erie and Tokmakjian Inc. entered into an Agreement dated September 14, 2012 and authorized by By-law No. 46-12, wherein Tokmakjian Inc. agreed to deliver conventional public transit services for the Town of Fort Erie (the "Agreement"); and

Whereas the Agreement has an Initial Term of five (5) years, expiring on September 30, 2017; and

Whereas the Agreement has automatically renewed for a further three (3) year term commencing October 1, 2017 and expiring on September 30, 2020 in accordance with Section 1.2 of the Agreement; and

Whereas Report No. IS-05-2017, as amended, was considered at the Council-in-Committee Meeting held on March 20, 2017 and subsequently authorized and approved by Council, to approve the quotation from Tokmakjian Inc. in the amount of \$2,149,399.00 (including 13% HST) for a three-year extension of the existing Agreement, and with the fare being phased in to \$2.75 on September 5, 2017 and \$3.00 on September 1, 2018; and

Whereas Report No. IS-05-2017, as amended, was reconsidered at the Council Meeting Held on July 17, 2017 and defeated; and

Whereas Council approved a new Resolution from Report No. IS-20-2017, as amended, to approve the quotation from Tokmakjian Inc. in the amount of \$2,493.861.00 (including 13% HST) for a three-year extension of the existing Agreement in accordance with Report No. IS-20-2017; and

Whereas it is deemed desirable to enter into an Extension and Amending Agreement with Tokmakjian Inc. for the provision of conventional public transit services;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

- 1. That the entry into an Extension and Amending Agreement with Tokmakjian Inc. for the provision of conventional public transit services for the Town of Fort Erie, for a three-year extension of the existing Agreement between the parties dated September 14, 2012, from October 1, 2017 to September 30, 2020, in a form acceptable to the Town Solicitor, is authorized and approved.
- **2. That** the Mayor and Clerk are authorized and directed to execute the Extension and Amending Agreement and to affix the corporate seal thereto.
