




## **Short Term Rental Requirements**



- Smoke/CO alarms where required (sleeping areas, etc. and service rooms)
- Annual fire extinguisher maintenance, and minimum size of 2A:10BC (5lb).
- Extinguishers wall mounted, visible, and easily accessible on every floor.
- Maximum number of bedrooms (3), and occupant load of 8 or less.
- Building issues, required railings, separations, renos with permits, etc. also determined through municipal records
- Ensure approved fire separations between multiple units
- Home address number visible from the road
- Evacuation routes clear inside and outside the building (Safe decks and stairs. Snow cleared at all exits?)
- Evacuation routes from basement bedrooms adequate
- Basement bedrooms require two exits. If a window is the second exit, it should open to the requirements of OBC 9.9.10.1.(1) - 0.35m2 (542 sq inches). (Approx. 23" x 23")
- Evacuation route drawings posted inside bedrooms
- Service rooms not used for storage unless designed for such
- Confirm accuracy of drawings submitted
- Housekeeping is fire safe. Combustibles, and flammable liquids, etc. stored in an approved manner
- No overloaded circuits, temporary wiring, suspicious electrical installations
- Complete an annual review of the fire evacuation plan
- Provide copies of Recreational Burn pamphlet and Fireworks pamphlet and a way for the owner or manager to request more as .pdf if needed
- Verify approved location of burn pit/device, and materials intended for burning (4 meters from property line/3 meters from combustible structures)
- Attached Set-Fines under the Fire Protection and Prevention Act and the Provincial Offences Act may be applied to any or all violations
