


	<p>WHAT WILL THIS AMENDMENT CHANGE:</p> <ul style="list-style-type: none"> • Permit the development of single detached dwellings within the draft plan approved Peace Bridge Subdivision (formerly Garrison Green Subdivision). • Change the zoning from R2(H) Zone to a site-specific R2(H) Zone with the following site-specific regulations: <ul style="list-style-type: none"> ○ Minimum lot area – 465.00 square metres; ○ Maximum lot coverage (1 storey dwellings) – 45%.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Town of Fort Erie in respect of the proposed Zoning By-law amendment before the By-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board, unless in the opinion of the Board, there are reasonable grounds to do so.
