

**The Municipal Corporation of the Town of Fort Erie**  
**Public Notice**  
**Appointments to Town Committees**  
**Opportunity to Engage in Your Community**

The Town Clerk is accepting applications from persons interested in serving on the committees listed below where vacancies exist. The appointments are for a four (4) year term ending November 14, 2022. The committees meet on a regular basis, usually once per month. All members of the committees act voluntarily.

- 1. Accessibility Advisory Committee: Vacancy – One (1) citizen appointee with a disability.**  
To provide advice to Council on its Accessibility Plan for all Municipal properties, facilities and services as regulations prescribe, and review site plans and drawings for development in the Town of Fort Erie.
- 2. Crystal Beach Beautification Committee: Vacancies – Four (4) citizen appointees.**  
To undertake beautification efforts in Crystal Beach in co-operation with the Crystal Beach BIA Board of Management and community.
- 3. Fort Erie Active Transportation Advisory Committee: Vacancy - Two (2) citizen appointees.**  
To provide a committee for residents, elected officials and health professionals to meet on a monthly basis for the purpose of improving conditions for people powered transportation (walking, biking, rollerblading) for utilitarian and recreational purposes.
- 4. Fort Erie Cemetery Advisory Committee: Vacancies – Three (3) citizen appointees.**  
To provide advice and make recommendations regarding the administration of Town cemeteries, cemetery budget, rate changes and major projects.
- 5. Museum and Cultural Heritage Advisory Committee consisting of Two Standing Committees: Museum Services and Municipal Heritage: Vacancy - One (1) citizen appointee.**  
To provide advice and recommendations for policy and plan development, conservation of built heritage and heritage trees, and act as public advocates in support of the Statements of Purpose for delivery of Museum Services and Built Heritage and Heritage Trees in accordance with the *Ontario Heritage Act*.

6. **Senior Citizen Advisory Committee: Vacancies – Three (3) citizen appointees specifically: one (1) representative from Italo-Canadian Seniors Club; one (1) representative from Black Creek Leisure Homes Seniors Group and one (1) representative from Fort Erie Native Friendship Centre Seniors.**

To establish a mechanism to fairly and equitably distribute financial assistance provided by the Town of Fort Erie to “Assist the Aged”, determine the need for increased senior citizen services and to assist in establishing mechanisms to adopt recommendations.

7. **Transit Advisory Committee: Vacancies – Two (2) citizen appointees specifically: One (1) regular user of FE Transit conventional services and one (1) regular user of FAST.**

To assess, advise and provide input on transit issues according to legislation, municipal by-laws, policies and standards. Recommendation areas include: routing, bus stop locations, service agreements and matters of policy via report to Council.
