BY-LAW NO. 96-2013

BEING A BY-LAW TO AMEND BY-LAW NO. 44-10 (TO ESTABLISH THE FORT ERIE ACTIVE TRANSPORTATION ADVISORY COMMITTEE AND TERMS OF REFERENCE) AND APPOINTMENT THERETO

WHEREAS By-law No. 44-10 was passed by the Municipal Council of the Town of Fort Erie on the 10th day of May, 2010 to establish the Fort Erie Active Transportation Advisory Committee and Terms of Reference, and

WHEREAS at the Fort Erie Active Transportation Advisory (FEAT) Committee meeting held September 10, 2013 Resolution No. 41/13 was passed to amend the composition as set out in Schedule "A" to By-law No. 44-10 (Terms of Reference) from 7 residents from the Fort Erie community, including at least one person with disability; one Fort Erie student representative attending a secondary institution and one Fort Erie student representative attending a post-secondary institution plus 1 Member of Council to 8 residents and 1 Member of Council, and

WHEREAS Resolution 42/13 was passed at the FEAT Committee meeting held September 10, 2013 recommending the appointment of Ms. Luisa Maria Galeano from an alternate member to a permanent member;

NOW THEREFORE the Municipal Council of The Corporation of the Town of Fort Erie hereby enacts as follows:

1. **THAT** Schedule "A" to By-law No. 44-10 (Terms of Reference) be hereby amended by deleting the Members section in its entirety and inserting in lieu thereof the following:


"Members

- One Member of Council;
- Eight residents from the Fort Erie community, including at least one person with disability; one Fort Erie student representative attending a secondary institution and one Fort Erie student representative attending a post-secondary institution."


2. **THAT** Ms. Luisa Maria Galeano be hereby appointed to the Fort Erie Active Transportation Advisory Committee for the period ending January 31, 2015.

3. THAT pursuant to the provisions of Sections 23.1 to 23.5 inclusive of the *Municipal Act, 2001*, as amended, the Clerk of the Town of Fort Erie is hereby authorized to effect any minor modifications or corrections solely of an administrative, numerical, grammatical, semantical or descriptive nature or kind to this by-law or its schedules as such may be determined to be necessary after the passage of this by-law.
