## BY-LAW NO. 128-2014

---

### BEING A BY-LAW TO AMEND BY-LAW NO. 44-10 AS AMENDED (FORT ERIE ACTIVE TRANSPORTATION ADVISORY COMMITTEE AND TERMS OF REFERENCE)

---

**WHEREAS** By-law No. 44-10 was passed by the Municipal Council of the Town of Fort Erie on the 10<sup>th</sup> day of May, 2010 to establish the Fort Erie Active Transportation Advisory Committee and Terms of Reference, and

**WHEREAS** By-law No. 44-10 was amended by By-law No. 96-2013 passed by the Municipal Council of the Town of Fort Erie on October 15, 2013, to modify the Committee composition to eight (8) residents from the Fort Erie community, including at least one (1) person with a disability, one (1) student representative attending a secondary institution and one (1) student representative attending a post-secondary institution, and

**WHEREAS** the Committee is having difficulty sustaining the specific membership criteria described in the Terms of Reference as it pertains to secondary and post-secondary student members, and deliver on its mandate;

**NOW THEREFORE** the Municipal Council of the Town of Fort Erie hereby enacts as follows:

1. **THAT** By-law No. 44-10, amended, is further amended by repealing Section 2 thereof in its entirety and replacing it with the following:
  - “2. **THAT** the Fort Erie Active Transportation Advisory Committee shall be composed of the following members:
    - One (1) Member of Council;
    - Eight (8) residents from the Fort Erie community, including one (1) person with disability;
    - Staff support: General Manager of CGDC, Town Planner, Health Promoter(s).”
2. **THAT** By-law No. 44-10, as amended, is further amended by repealing the “Members” section of Schedule “A” (Terms of Reference) in its entirety and inserting in lieu thereof the following:

“Members:

  - One (1) Member of Council;
  - Eight (8) residents from the Fort Erie community, including one (1) person with disability;
  - Staff support: General Manager of CGDC, Town Planner, Health Promoter(s).”
3. **THAT** pursuant to the provisions of Sections 23.1 to 23.5 inclusive of the *Municipal Act, 2001*, as amended, the Clerk of the Town of Fort Erie is hereby authorized to effect any minor modifications or corrections solely of an administrative, numerical, grammatical,

semantical or descriptive nature or kind to this by-law or its schedules as such may be determined to be necessary after the passage of this by-law.
