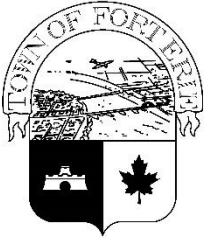

By-law No. 77-2021

Being a By-law to Appoint Gerald Moore and Barbara Mocny as Building Inspectors for The Corporation of the Town of Fort Erie

Whereas the *Building Code Act, 1992*, section 3 provides that the council of each municipality is responsible for the enforcement of the *Act* in the municipality and shall appoint such inspectors as are necessary for the enforcement of the *Act* in the areas in which the municipality has jurisdiction; and

Whereas it is desirable to appoint Gerald Moore and Barbara Mocny as Building Inspectors;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

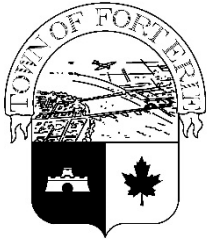
1. **That** Gerald Moore and Barbara Mocny are appointed Building Inspectors for The Corporation of the Town of Fort Erie and they shall perform the duties and exercise the powers of Building Inspector in accordance with the provisions of the *Building Code Act, 1992*.
2. **That** Gerald Moore and Barbara Mocny are appointed as Municipal Law Enforcement Officers and Provincial Offences Officers while in the discharge of their duties.
3. **That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

By-law No. 78-2021

Being a By-law to Confirm the Actions of Council at its Special Meeting Held on June 14, 2021

Whereas it is desirable to have the actions and proceedings of Council adopted, ratified and confirmed by by-law;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. That the actions of Council at its Special meeting held on June 14, 2021 including all motions, resolutions and other actions are adopted, ratified and confirmed as if they were expressly embodied in this by-law, except where the law requires the prior approval of the Ontario Municipal Board or other authority.
2. **That** where no individual by-law has been or is passed with respect to the taking of any action authorized in or with respect to the exercise of any powers by the Council, then this by-law is deemed for all purposes to be the by-law required for such authorization or exercise of any powers.
3. **That** the Mayor and officers of The Corporation of the Town of Fort Erie are authorized and directed to do all things necessary to give effect to such actions or to obtain approvals where required.
4. **That** except where otherwise provided, the Mayor and the Clerk are authorized and directed to execute all documents arising from such actions.
5. **That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.
