


# Notice of Complete Application & Public Meeting Zoning By-law Amendment 0 Burleigh Road North Owner: Roman Catholic Episcopal Corporation St Catharines Agent: Alexis Banfai

## PROPOSED CHANGE

To rezone the subject property to a sitespecific Residential 1 (R1) Zone to permit development of a two storey single detached dwelling on an existing undersized lot of record in the Ridgeway-Thunder Bay neighbourhood. The total floor area of the proposed dwelling is 126.14 sq m (combined area of both floors, excluding the attached garage and porches).

The proposed zoning will permit development of a single detached dwelling with site-specific provisions for the following:



- reduced lot frontage 10.50 m for an existing non-conforming lot of record
- recognize existing lot area 409.30 sq m
- a reduced interior side yard setback for a two storey dwelling on an infill lot 2.00 m
- increased projection of a covered porch into an exterior side yard 1.52 m
- decrease to the minimum distance between a driveway and an intersection of street lines – 5.50 m

#### **REVISION OF APPLICATION AND ADJOURNED PUBLIC MEETING**

A public meeting for this application that took place on August 31, 2020 was adjourned so the Agent could submit finalized designed plans for the proposed dwelling. The Agent revised their application and the requested site-specific zoning provisions are outlined above. The public meeting is rescheduled for November 16, 2020.
