Two (2) areas of impacted soil were identified as exceeding applicable criteria: Area 1 surrounding B-TP-1 with soil impacted by Metals (by ICP) and PAHs, and Area 2 surrounding borehole C-BH-4 with soil impacted by Metals (by ICP). Excavation via backhoe commenced on November 2nd, 2021 and continued to November 4th, 2021 to remove contaminated soils. Verification wall and floor sampling was performed at both Areas. All floor and wall samples met the applicable criteria.
