

# The Municipal Corporation of the Town of Fort Erie

By-law No. 10-2018

## Being a By-law to Amend Zoning By-law No. 129-90, as Amended – Removal of Holding Provision Willow Trail Subdivision (2298423 Ontario Inc. – Wilfred Goldlust)

**Whereas** the Municipal Council of The Corporation of the Town of Fort Erie passed By-law No. 44-06 on the 27<sup>th</sup> day of March, 2006, rezoning certain lands within the Willow Trail subdivision generally located on the north and south side of Hibbard Street, west of Prospect Point Road North to "Residential Multiple 1 RM1-346 (H) Zone" and "Residential Multiple 1 RM1-347 (H) Zone" with a Holding provision preventing the development of the lands until Council approved a Subdivision Agreement for the lands; and

**Whereas** the Municipal Council of The Corporation of the Town of Fort Erie passed By-law No. 107-14 on the 21<sup>st</sup> day of July, 2014, approving a subdivision agreement between The Corporation of the Town of Fort Erie and 2298423 Ontario Inc. for the Willow Trail Plan of Subdivision; and

**Whereas** 2298423 Ontario Inc., the owner, requested the holding provision be removed in a letter dated January 10, 2018;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

- That Schedule "A" of By-law 129-90 as amended is further amended by changing the zoning on the lands shown on the attached Appendix "1" from "Residential Multiple 1 RM1-346 (H) Zone" and "Residential Multiple 1 RM1-347 (H) Zone" to "Residential Multiple 1 RM1-346 Zone" and "Residential Multiple 1 RM1-347 Zone".
- 2. That the Clerk of the Town is authorized to effect any minor modifications, corrections, or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.
