



# The Municipal Corporation of the Town of Fort Erie

## By-law No. 26-2018

---

### Being a By-law to Amend Traffic By-law No. 2000-89 Increase of Parking Time Limit within the Bridgeburg Station Downtown Business Improvement Area and Increase of Speed Limit on Ridge Road North

---

**Whereas** By-law No. 2000-89, as amended, provides for the regulation of traffic and parking on highways in the Town of Fort Erie; and

**Whereas** Report No. IS-04-2018 was considered at the Council-in-Committee Meeting held on February 5, 2018 and subsequently authorized and approved by Council, to amend Schedule “E” of By-law No. 2000-89 to increase the time limit for limited parking within the Bridgeburg Station Downtown Business Improvement Area from 2 hours to 3 hours; and

**Whereas** Report No. IS-05-2018 was considered at the Council-in-Committee Meeting held on February 5, 2018 and subsequently authorized and approved by Council, to amend Schedule “U” of By-law No. 2000-89 to increase the speed limit along a portion of Ridge Road North from the south limit of Nigh Road to the north limit of Dominion Road from 40 km/h to 50 km/h; and

**Whereas** it is deemed desirable to amend Traffic By-law No. 2000-89, as amended, accordingly;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** Schedule “E” to By-law No. 2000-89, as amended, is further amended by replacing the Jarvis Street South side and Klauck Street East side maximum period permitted with the following in the Table:

2. **That** Schedule “U” to By-law No. 2000-89, as amended, is further amended by replacing the rate of speed for Ridge Road North between the South limit of Nigh Road to the North limit of Dominion Road with the following in the Table:

3. **That** this by-law shall be enforceable upon the installation of the appropriate signage as required for each of the above amendments.
4. **That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.
