

## The Municipal Corporation of the Town of Fort Erie

By-law No. 87-2018

Being a By-law to Authorize the Entry into and Execution of an Agreement with Jeffrey Kline (B58-59/17 F.E. - 0 Dominion Road)

**Whereas** Jeffrey Kline is the registered owner of lands legally described as Part of Lot 15, Concession 1 Lake Erie, Bertie, designated as Part 1 on 59R-11201, Fort Erie, being all of PIN 64201-0305 (LT); and

**Whereas** Jeffrey Kline (the "Applicant") made an Application to the Committee of Adjustment for Consent for the purpose of creating a new lot, legally described as Part of Lot 15, Concession 1 Lake Erie, Bertie, designated as Part 1 on 59R-16170, Fort Erie, being part of PIN 64201-0305 (LT) (the "Lands"); and

Whereas pursuant to the Decision of the Town of Fort Erie Committee of Adjustment, File No. B59/17 F.E. (in conjunction with B58/17 F.E.), the Applicant must enter into an Agreement with, and suitable to, The Corporation of the Town of Fort Erie, whereby the Applicant must obtain a Building Permit for a new structure on the Lands for a permitted use under section 8.2 of Zoning By-law 129-90 of the Town of Fort Erie within one (1) year of the date of issuance of the Certificate of Consent by the Secretary-Treasurer; and

**Whereas** it is deemed desirable and necessary for The Corporation of the Town of Fort Erie to enter into such an Agreement with the Applicant, in order for the Applicant to fulfill a condition of the severance:

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

- 1. That the entry into an Agreement with Jeffrey Kline requiring him to obtain a Building Permit for the Lands, legally described as Part of Lot 15, Concession 1 Lake Erie, Bertie, designated as Part 1 on 59R-16170, Fort Erie, being part of PIN 64201-0305 (LT), within one (1) year of the date of issuance of a Certificate of Consent by the Secretary-Treasurer, and in a form satisfactory to the Town Solicitor, is authorized and approved.
- **2. That** the Mayor and Clerk are authorized and directed to execute the Agreement and any other documentation related thereto, and to affix the corporate seal thereto.
- **That** upon final passage of this by-law, the Town Solicitor shall cause same to be registered in the Land Registry Office.

**4. That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 16<sup>th</sup> day of July, 2018.
