## By-law No. 146-2018

### Being a By-law to Appoint Acting Mayors for the 2018-2022 Term of Council

---

**Whereas** the *Municipal Act, 2001*, S.O. 2001, c. 25, section 242 provides that a municipality may, by by-law or resolution, appoint a member of the council to act in the place of the head of council or other member of council designated to preside at meetings in the municipality's procedure by-law when the head of council or designated member is absent or refuses to act or the office is vacant, and while so acting such member has all the powers and duties of the head of council or designated member, as the case may be, with respect to the role of presiding at meetings; and

**Whereas** Section 3.2 of Council Rules of Procedure By-law No. 36-2016 provides for the appointment of Acting Mayors on a rotating basis;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** Acting Mayors for the Town of Fort Erie for the 2018-2022 term of Council are appointed as set out in Schedule "A" to and forming part of this by-law.
2. **That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

**Read a first, second and third time and finally passed this 3<sup>rd</sup> day of December, 2018.**
