

The Municipal Corporation of the Town of Fort Erie

By-law No. 13-2019

Being a By-law to Amend Dog Regulation By-law No. 119-97, as amended, to Provide for Set Fine Charges for Animals Kept in Confined Spaces and in Vehicles

Whereas By-law No. 119-97, as amended, was passed by the Municipal Council of the Town of Fort Erie on the 18th day of August, 1997 to regulate, restrict and prohibit the keeping and running at large of dogs in the Town of Fort Erie; and

Whereas By-law No. 74-2018 was passed by the Municipal Council of the Town of Fort Erie on the 28th day of May, 2018 to amend Dog Regulation By-law No. 119-97, as amended, with respect to animals being kept in confined spaces and in vehicles; and

Whereas at the time that By-law No. 74-2018 was passed, the schedule which would provide Provincial Offences short form set fines was being compiled and therefore was not included with the by-law; and

Whereas it is deemed necessary to further amend By-law No. 119-97 to include set fine charges for animals kept in confined spaces and in vehicles;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

- **1. That** By-law No. 119-97, as amended, is further amended by adding Schedule "B" thereto, attached as Schedule "A" to this by-law.
- **2. That** the new set fines shall come into force and effect upon receipt of the Judge's Order issued by the Ministry of the Attorney General.
- **3. That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 11th day of February, 2019.
