By-law No. 5-2020

Being a By-law to Amend Zoning By-law No. 129-90, as Amended – Removal of Holding Provision Lulongping Gardens Phase 1 (Yiliming International Real Estates Ltd. – Longping Lu)

Whereas the Municipal Council of The Corporation of the Town of Fort Erie passed By-law No. 72-2015 on the 11th day of May, 2015, rezoning certain lands within the Lulongping Gardens Phase 1 (formerly Spears Garden) subdivision generally located north of Regional Road 3 (Garrison Road), east of Pettit Road to "Residential 2 Holding (R2-525H) Zone" and "Residential Multiple 1 Holding (RM1-526H) Zone" with a Holding provision preventing the development of the lands until Council approved a Subdivision Agreement for the lands; and

Whereas the Municipal Council of The Corporation of the Town of Fort Erie passed By-law No. 122-2018 on the 24th day of September, 2018, approving a subdivision agreement between The Corporation of the Town of Fort Erie and Yiliming International Real Estates Ltd. for Lulongping Gardens Phase 1; and

Whereas Upper Canada Consultants, the agent for the owner, requested the holding provision be removed in a letter dated January 3, 2020;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

 That Schedule "A" of By-law 129-90 as amended is further amended by changing the zoning on the lands shown on the attached Appendix "1" from "Residential 2 Holding (R2-525H) Zone" and "Residential Multiple 1 Holding (RM1-526H)" to "Residential 2 (R2-525) Zone" and "Residential Multiple 1 (RM1-526) Zone".

By-law No. 5-2020

2. That the Clerk of the Town is authorized to effect any minor modifications, corrections, or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 20th day of January, 2020.
