

The Municipal Corporation of the Town of Fort Erie

By-law No. 69-2021

Being a By-law to Authorize Applications for the Cancellation, Reduction or Refund of Taxes Levied for the Years 2018, 2019 and 2020

Whereas pursuant to Sections 357 and 358 of the *Municipal Act, 2001,* as amended, an owner or another person with an interest in a property may make application for the cancellation, reduction or refund of taxes levied in respect of an event that affects the assessment or an overcharge; and

Whereas Report No. CS-05-2021 was considered and approved at the Council-in-Committee Meeting held May 17, 2021 for the cancellation, reduction or refund of taxes and penalties in the amount of \$18,395.44;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

- **1. That** the applications received for tax adjustments totalling \$18,395.44 for various roll numbers attached as Schedule "A" to this by-law, are accepted and approved.
- 2. That the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 31st day of May, 2021.
