By-law No. 74-2021

Being a By-law to Amend Fees and Charges By-law No. 40-09, as amended (Dog & Cat Licensing Fees & Charges)

Whereas By-law No. 40-09, as amended, was passed by the Municipal Council of The Corporation of the Town of Fort Erie on March 9, 2009, to establish fees and charges for various services provided by the Town of Fort Erie; and

Whereas Report No. PDS-17-2021 was considered and partially approved at the Council meeting held on March 22, 2021 to implement a voluntary one-time licensing fee for cats of \$20.00; and

Whereas it is deemed desirable to further amend By-law No. 40-09 to approve the new fee;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** the following Schedule to By-law No. 40-09 as amended, is repealed:

Schedule "PDS-G" Dog Licensing Fees and Charges

and replaced with the Schedule attached hereto as **Schedule "A" (PDS-G Dog and Cat Licensing Fees and Charges)**, and the fees and charges contained therein are hereby authorized, approved, and established, effective upon passage of this by-law.

2. **That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.

Read a first, second and third time and finally passed this 31st day of May, 2021.

The *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides municipalities with authority to establish and impose fees and charges.

The following fees shall **NOT** be adjusted annually based on the Statistics Canada, *Consumer Price Index (CPI)*.
