By-law No. 158-2021

Being a By-law to Amend the Fort Erie Senior Citizens Advisory Committee By-law No. 23-10, as amended (Composition)

Whereas By-law No. 23-10, was passed by the Municipal Council of the Town of Fort Erie on February 22, 2010, to re-establish the Senior Citizens Advisory Committee, as amended; and

Whereas Council considered and approved Report No. COS-03-2020 at the Council-in-Committee meeting held on March 9, 2020 to alter the composition of the Fort Erie Senior Citizens Advisory Committee; and

Whereas it is deemed desirable to make the aforesaid amendment to By-law No. 23-10, as amended;

Now therefore the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

1. **That** Section 3 of By-law No. 23-10, as amended, is repealed and replaced with the following:

3. **“That** the Senior Citizens Advisory Committee shall be compromised of the following:

 - 1 rep “’96’ers” of Fort Erie”;
 - 3 reps “Beachcombers” of Ridgeway”;
 - 1 rep “Royal Canadian Legion, Branch 71”;
 - 1 rep “Royal Canadian Legion, Branch 230”;
 - 1 rep “Fort Erie Native Friendship Centre Seniors”;
 - 4 reps “Community Representatives (at large)”;
- and

consideration may be given to filling vacancies in Seniors Groups by appointment of additional Community Representatives (at large).”

- 2. That** the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions, solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.
