

## The Municipal Corporation of the Town of Fort Erie

By-law No. 33-2022

Being a By-law to Amend Zoning By-law No. 129-90, as amended 85 Idylewylde Street Stella Unger - Agent Eduard Unger - Owner

**Whereas** an application was received from Stella Unger (Agent) for Eduard Unger (Owner) to amend the Town's Comprehensive Zoning By-law No. 129-90 as amended, for the lands municipally known as 85 Idylewylde Street; and

**Whereas** a Public Meeting pursuant to Section 34(12) of the *Planning Act*, R.S.O. 1990, c.P.13 was held on August 23, 2021; and

**Whereas** it is deemed desirable to amend the Comprehensive Zoning By-law No. 129-90 as amended, pursuant to the recommendations of Report No. PDS-12-2022 considered and approved at the Council-in-Committee meeting held on March 21, 2022;

**Now therefore** the Municipal Council of The Corporation of the Town of Fort Erie enacts as follows:

- 1. That Schedule "A" of By-law No. 129-90, as amended, is further amended by changing the zoning of the lands municipally known as 85 Idylewylde Street and shown on the attached Appendix "1" from "Residential 2 (R2) Zone" to "Residential 3 (R3-741) Zone".
- 2. That By-law No.129-90 as amended, is further amended by adding to "Section 13 Residential 3 (R3) Zone" Subsection "Exceptions to the Residential (R3) Zone" the following exception:

## "R3-741 (33-2022) 85 Idylewylde Street

These lands are zoned "Residential 3 (R3-741) Zone" and all of the provisions that relate to lands zoned "Residential 3 (R3) Zone" by this by-law shall apply to those lands zoned "Residential 3 (R3-741) Zone" subject to the following special provision:

a) Maximum Lot Coverage - 46.8%"

3. That the Clerk of the Town is authorized to effect any minor modifications, corrections or omissions solely of an administrative, numerical, grammatical, semantical or descriptive nature to this by-law or its schedules after the passage of this by-law.
