## NOTICE OF PASSING OF DEVELOPMENT CHARGES BY-LAW BY THE CORPORATION OF THE TOWN OF FORT ERIE

DEVELOPMENT CHARGES ACT, 1997, S.O. 1997, c.27

**TAKE NOTICE** that on Monday, March 18<sup>th</sup>, 2019, the Council of The Corporation of the Town of Fort Erie passed By-law No. 47-2019 under Section 2 of the *Development Charges Act, 1997*, which imposes Town-wide development charge rates.

**AND TAKE NOTICE** that any person or organization may appeal to the Local Planning Appeal Tribunal in respect to the by-law by filing with the Clerk of The Corporation of the Town of Fort Erie, not later than Monday, April 29, 2019, a notice of appeal setting out the objection to the by-law and the reasons in support of the objection.

The charges in the aforementioned by-law will apply to all new residential and non-residential development, subject to certain terms, conditions and limited exemptions as identified therein.

Development charges are levied against new development to pay for the increased capital costs related to the provision of such Town services as Library, Fire Protection, Parks and Recreation, Public Works and Fleet, Parking, Transit, Administration, Roads and Related, Stormwater Drainage and Control, Wastewater and Water Supply Services. The development charges imposed by the by-law are as follows:
