| | PROPOSAL The Town has initiated amendments to the Town of Fort Erie Official Plan and Zoning By- law 129-90 to implement recommendations to address the emergence of Short-Term Rentals (STRs) within the Town of Fort Erie, pursuant to Sections 17 and 34 of the Planning Act, R.S.O. 1990, as amended. |
| | The Official Plan Amendment (OPA) defines two types of STRs, outlines general policy goals and identifies where STRs are generally permitted. The Zoning By-law Amendment (ZBLA) defines STRs as commercial uses and permits them in specific zones as well as establishes regulations including parking, and size limitations. |
| | The amendments will apply to the entire area of the Town of Fort Erie. The Town's current Official Plan, which was approved in 2011, and the current Zoning By-law 129-90 will be amended. |
