Are you interested in sharing your opinion on how you would like to see the Crystal Beach Neighbourhood grow?

Town Council is looking to complete a Crystal Beach Secondary Plan, A Secondary Plan is a land-use document that guides future development and forms part of the Town's Official Plan.

Town Staff is looking for 12 to 15 people who live in Crystal Beach year-round to participate in a new Crystal Beach Neighbourhood (CBN) Focus Group. Focus Group members should be open-minded and focused on their community at large.

Members will be asked to provide opinions in the following areas:

- Overall land use arrangement for the Crystal Beach Neighbourhood community
- Policy direction on different forms of housing that support age-inplace options and opportunity
- Residential densities and location where singles, semis, townhomes or apartment buildings are best situated
- Where commercial areas belong, where their limits should be and how we may best support them through mixed land-use:
- Seeking solutions to seasonal parking concerns:
- How best to integrate open space and recreational assets of the community to benefit residents, commercial and tourism interests:
- Environment to reinforce appropriate protection of environmental or natural feature areas:
- Transportation consideration (such as roads, sidewalks, trails) and the overall connectivity.

Members will participate in a strategic planning exercise that will help generate:

- A Vision statement
- Goals
- Objectives
- Priorities

CBN Focus Group members will...

- Participate in a four hour strategic focus exercise
- Meet at different times throughout the Secondary Plan's development (Meeting dates are still to be determined)

- Your name, address, phone and/or email
- Whether you consider yourself a longtime resident, new resident, business owner or developer (please choose only one of the four mentioned that best suits you or the category that you would like to represent)



A brief description of your background, specific interests, experience and/or any other involvement within the Fort Erie community. Also, please identify if you are a member of a community group or other association active in Crystal Beach.

Once all submissions are received, Town staff will prepare a report for Council's consideration on making the selections to fill Focus Group membership. The names of those submitting their expression of interest and those selected to participate will become part of public record and may be published in relation to this planning exercise.
