We have audited the Corporation of the Town of Fort Erie's compliance as at December 31, 2012 with the criteria established by the terms and conditions described in sections 3.1, 5.1, 5.4, 6.2, 6.5 to 6.9, 7.1 a to g, 7.2, 8.1 to 8.3, 9.1, 9.2 and 10.2 of the Municipal Funding Agreement for the Transfer of Federal Gas Tax Revenues Under the New Deal for Cities and Communities dated April 26, 2010 between the Association of Municipalities of Ontario and the Corporation of the Town of Fort Erie. Compliance with the criteria established by the provisions of the agreement is the responsibility of the management of the Corporation of the Town of Fort Erie. In our opinion, as at December 31, 2012, the Corporation of the Town of Fort Erie is in compliance, in all material respects, with the criteria established by the terms and provisions described in sections 3.1, 5.1, 5.4, 6.2, 6.5 to 6.9, 7.1 a to g, 7.2, 8.1 to 8.3, 9.1, 9.2 and 10.2 of this agreement.
